

Wedding Dreams Fall Contest 2011: Win a Trip for Two to Jamaica

1) **Agreement:** These rules govern “the trip for two to Jamaica” (the “**Contest**”). No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest rules and the decisions of the Contest judges, which decisions shall be final and binding upon all entrants.
